

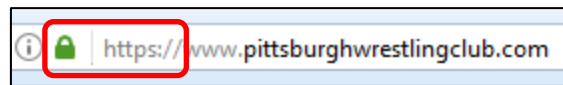


### Pittsburgh Wrestling Club Privacy Policy

In connection with your transaction, Pittsburgh Wrestling Club (PWC) may obtain information about you as described in this notice, which we handle as stated in this notice.

We may collect personally identifiable information such as name, postal address, telephone number, e-mail address, date of birth, etc. for club purposes. This personal information is collected and used by Pittsburgh Wrestling Club (PWC) staff and (or) third parties for the purpose of facilitating a relationship, ecommerce or a business transaction(s).

Our website uses Secure Sockets Layer (SSL), the industry-standard security protocol used to communicate with browsers) to transmit personal information. Data is strongly encrypted during transmission to ensure that personal and payment information is secure. Industry-standard data encryption techniques are used to protect personal information on our servers. Secure Sockets Layer (SSL) capable browsers typically have a symbol (or padlock) on the browser window (see below) to indicate when they are in a secure mode. In addition, the URL will begin with "https:" for all browsers.
